#### LETTER OF CENSURE

Dear Trooper Victor:

On April 7, 2020, you were operating your assigned Division vehicle when you were involved in a troop car accident. This accident has been reviewed at Troop Headquarters and it was determined to have been preventable on your part. On September 11, 2020, you appeared before me, executed a waiver, and requested that I adjudicate the disciplinary action.

The accident occurred when you were traveling on East Main Street in the Town of Wallkill behind another Division vehicle, 2F70, and another vehicle in front of that. The front car stopped abruptly for a squirrel crossing the road. You braked but your vehicle, 2F60, struck the rear of 2F70, subsequently pushing it into the car in front of him. Fortunately, there were no injuries. However, as professional driver, you are expected to drive more carefully.

It is my decision that you receive a letter of censure for your actions. Additionally, I have determined that you would benefit from instruction with our Troop Safety Officer. I trust that you will drive more cautiously in the future.

On April 7, 2020 at approximately 9:40 PM, Trooper THOMAS S. VICTOR (SP Middletown 1 shift) operating 2F60 and Trooper THOMAS J. MOZER (SP Middletown 1 shift) operating 2F70 were involved in a three car PIAA on East Main Street in the Town of Wallkill. Sergeant/Station Commander THOMAS A. FORTUNA, Sergeant LEE C. GUAGENTI and I, Sergeant/Station Commander MARK A. PRESTIGIACOMO, were advised and responded to investigate.

Investigation revealed that 2F60 (V-1), 2F70 (V-2), and a 2017 Honda Civic bearing NY registration HWT4495 (V-3) operated by CHELSEA A. SCOTT were traveling eastbound on East Main Street T/Wallkill when V-3 came to a sudden stop for an uninvolved vehicle ahead which stopped abruptly for a squirrel crossing the road. Troopers VICTOR and MOZER also braked, at which time 2F60 struck the rear of 2F70 subsequently pushing 2F70 into the rear of V-3.

I interviewed Troopers VICTOR and MOZER who stated that they were both traveling eastbound when V-3 came to a sudden stop causing them to brake. Trooper VICTOR stated that he attempted to brake and veer to the right, but was unable to avoid 2F70. Members provided GENL-7 memoranda which are enclosures in this report.

Sergeant GUAGENTI interviewed CHELSEA SCOTT who stated that she stopped suddenly for a vehicle ahead of her which stopped for a squirrel crossing the road. SCOTT stated that she believed her vehicle was struck by 2F70, but she did not observe any damage and was uninjured. A supporting deposition was secured from SCOTT which is an enclosure in this report.

Sergeant/Station Commander FORTUNA interviewed independent witness ERIC TONESSEN who corroborated the event as described above. A supporting deposition was secured from TONESSEN which is an enclosure in this report.

Photographs of the scene and involved vehicles were secured, as well as an accident report completed, which are enclosures in this report.

Estimates were received from T&C Auto Body in Middletown, NY in the amount of \$6,908.66 for 2F60 and \$13,590.64 for 2F70 which are enclosures in this report.

Subject: DIVISION VEHICLE PIAA

On Tuesday, April 7, 2020, I was working a 1 shift out of SP Middletown operating marked New York State Division vehicle 2F60, a 2017 Ford Explorer. At approximately 9:40 a.m. I was driving eastbound on East Main St, in the Town of Wallkill. At that time, 2F70 operated by Trooper THOMAS J. MOZER was in front of me along with a blue 2017 Honda Civic bearing New York registration HWT4495 operated by CHELSEA A. SCOTT in front of him. I observed Trooper MOZER come to a stop due to SCOTT abruptly stopping. I attempted to avoid 2F70 by slowing down and moving onto the shoulder but was unable to avoid striking the rear passenger side bumper. Said collision caused damage to the front driver side bumper of 2F60 and rear passenger side bumper of 2F70. The collision subsequently caused the airbags to deploy in 2F60. Sergeant/Station Commander THOMAS A. FORTUNA and Sergeant LEE C. GUAGENTI responded to the scene for the investigation. Both 2F60 and 2F70 were towed from the scene.

At approximately 9:40AM I was driving eastbound on East Main St, in the Town of Wallkill. A Vehicle ahead of me came to a sudden stop at which time I braked. Marked Division vehicle 2F60 being operated by Trooper THOMAS S. VICTOR II, was traveling behind me. Trooper VICTOR was unable to stop in time, striking 2F70 in the rear. Due to the impact, 2F70 was pushed into the rear of the stopped vehicle in front of me, a blue 2017 Honda Civic bearing New York registration HWT4495 being operated by CHELSEA A. SCOTT. 2F70 sustained rear end damage as well as front end damage to the push bumper. 2F60 sustained front end damage. I did not incur any injuries resulting from the accident.
