

### Francisco Castaneda Chronology

- 1982: Entered U.S. when he was 10 years old with his mother

- **November 1, 2006:** Mr. Castaneda shows correctional officers blood in his boxer shorts and describes the pain he is experiencing. One officer takes Mr. Castaneda to medical, but Mr. Castaneda is denied entry by another officer, who informs him that without a sick call slip Mr. Castaneda cannot be seen. Mr. Castaneda informs the officer that he is bleeding and in pain, and that he submitted a sick call slip four days earlier but received no response. Mr. Castaneda is told to wait and see what happens.
