On 11-27-11 I was hospital watch security officer on duty at Salem Memorial Hospital in regard to Inmate Halverson Michael #7299859. Inmate Halverson was on approx 2:17 pm. Per the family thru Dr. Shelton, Mr. Halverson died at approx. 2:30 pm. I had called Lt. Goodman with updates and instructions regarding this procedure. A crime scene log was started and the room was evacuated and secured until State Police and the Medical Examiner arrived. At 3:35 pm, the Medical examiner and state police released the body. I remained at the scene until Alternative burial and cremation services arrived and took possession of the body at 5:15pm.
